1. Definitions

- 1.1 EJC: European Juggling Convention, the organized event for which The EJA sells Tickets;
- 1.2 Organiser: Bruneck Kronplatz Tourismus, the legal entity organising the EJC with its registered office in Bruneck, Italy;
- 1.3 Ticket: the document that serves as an admission ticket for the EJC, including an electronic Ticket;
- 1.4 'The EJA': The European Juggling Association, the non-profit association with its registered office in Amsterdam, the Netherlands.

2. Formation of a Contract

- 2.1 Tickets for the EJC can be obtained from the webshop of the EJA, https://prereg.eja.net.
- 2.2 Upon the purchase of a Ticket the Terms and Conditions of the Organiser apply (this document).

3. Access to the venue

- 3.1 The e-ticket must be presented at the registration desk. At that point, ticket details and payment are checked and the e-ticket is exchanged for the event's wristband (badge).
- 3.2 Only the badge provides the right of access to the venue.
- 3.3 The badge may only be collected in person by the participant, who must identify themselves with a valid government-issued identification document,
- 3.4 The badge will only be provided if the participant presents a signed copy of the waiver of responsibility.
- 3.5 In the case of children and juveniles under the age of 16, the badge will only be provided to legal guardians or to the adult supervisor named in the written Declaration of Consent (the form "Participants under 16"). Children and juveniles under the age of 16 may not be present at the venue unless accompanied by their legal guardian or legitimate adult supervisor. The supervisor must provide a copy of an identification document of the child's legal guardian in addition to their own identification document.
- 3.6 Juveniles aged 16 and 17 will be provided with a badge only if they present a written declaration of consent (Form "Participants aged 16 and 17") from their legal guardians as well as a copy of their valid identification documents.
- 3.7 In the event that declarations of consent or copies of identification documents as specified in 3.5 and 3.6 are not presented, a badge will not be provided and entry to the venue will be denied. The ticket price will not be refunded.
- 3.8 Lost badges will not be replaced.
- 3.9 Badges are not transferable. Misuse may lead to the badge being confiscated and the participant thereby being barred from the event

4. General rules at the venue

- 4.1 The Organiser holds domiciliary rights within the venue. SITEOWNER site rules are applicable. The organiser's instructions, as well as those of its personnel and stewards and those of SITEOWNER personnel are to be followed.
- 4.2 Dogs are not permitted anywhere on the site.

- 4.3 Open fires are prohibited, except in areas explicitly marked. All participants are requested to participate in ensuring fire safety on the site.
- 4.4 Consumption of illegal drugs is prohibited.
- 4.5 Consumption of alcohol is prohibited for children and juveniles. Applicable laws will be enforced. Alcohol consumption is prohibited entirely within the camping area reserved for children's and youth circuses and families.
- 4.6 The organiser reserves the right to bar persons who violate sections 4.1 to 4.5 from the site. The admission price will not be refunded in these cases.
- 4.7 The Organiser reserves the right to bar persons strongly under the influence of alcohol from the event or from individual programme items, as well as from the venue. In this case the admission price will not be refunded.

5. Photographic and Audio Recordings

5.1 Should photographs be taken or audio recordings be made by authorised persons during the event, the participant consents to being recorded and/or photographed and to the material being published and otherwise used without compensation.

6. Liability

- 6.1 Participation in the event is at the participant's own risk. Participants are responsible for monitoring their state of health. The Organiser is liable only in the event of wilful conduct or gross negligence.
- 6.2 The Organiser is not responsible for lost or stolen property.
- 6.3 Participants are liable for any damages caused by them as specified by law.

7. Final clauses

- 7.1 The event and these terms are subject to Italian law.
- 7.2 In case of doubt, the English version of these terms is binding.
- 7.3 Place of jurisdiction is Bolzano.
- 7.4 In the event that individual clauses or rules on this website are invalid or become invalid at a later date, the rule that is valid and best fits the invalid rule in terms of objective and economic prudence, shall replace it.
